

## **Revocation of Voter Registration and Examples of Letters**

Last voted over 2 years ago? Your name has most likely been removed from the Voter Registry.

Lived and voted in more than one state? Some are choosing to notify each state they have ever lived in and had registered to vote.

Anna Von Reitz Article states to notify the State of State Voter Registration Office.

You may also want to notify the US Election Assistance Commission.

Do a “search” as **your state may require a specific form.**

To confirm receipt, use Certified Mail Return Receipt or Registered Mail.

No response is a response! **KEEP RECORDS of DATES.**
